CITY COUNCIL CALLED MEETING
July 19, 2010

The City Council of the City of Talladega met in a called meeting on Thursday, July 19, 2010 at 5:00 p.m., in the City Hall Auditorium, the regular place for such meetings. The meeting was called to order and the following were present: Council President Horace Patterson, Councilman Donnie Miller, Councilman Jimmy Davis, and Interim City Manager Brian Muenger.

Motion by Councilman Davis with a second from Councilman Miller to excuse the absence of Councilman Grissett and Councilman Tucker. AYES: All

Resolution #2069 to support the Talladega County Commission, City of Lincoln and the Coosa Valley Recreation Board to become a Public Park Authority for the Coosa River Annex property. **(tabled from last meeting until rewritten as suggested by Councilman Tucker)**

Motion by Councilman Miller with a second from Councilman Davis to adopt Resolution #2069. Roll Call. AYES: All

Resolution #2071 to award contract to McCartney Construction Company Inc. for various resurfacing project (Project No. ST-061-999-011) for the bid price of \$1,286,085.45.

Motion by Councilman Miller with a second from Councilman Davis to accept Resolution #2071. Roll Call. AYES: All.

Resolution #2072 to approve a contract with Neel-Schaffer Engineering for construction engineering and inspection services for Street Resurfacing and Bridge Replacement Project #ST-061-999-11.

Motion by Councilman Davis with a second from Councilman Miller to accept Resolution #2072. Roll Call. AYES: All.

Resolution #2073 to appoint W. Brian Muenger as Temporary Acting City Manager.

There was some discussion about correspondence received by current Temporary City Manager Chris Stone and that Mr. Stone would return to his position as Community Development Director during medical absence from work and until he had time to meet with the City Council. The appointment of Brian Muenger as Temporary Acting City Manager would be in force until further notice from the City Council.

Motion by Councilman Miller with a second from Councilman Davis to accept Resolution #2071. Roll Call. AYES: All.
