

**ORDINANCE NO. 1684**

AN ORDINANCE TO AMEND ORDINANCE NO. 1667 - THE BUSINESS LICENSE CODE OF THE CITY OF TALLADEGA, ALABAMA, FOR THE BUSINESS LICENSE YEAR 2011 AND EACH SUBSEQUENT YEAR THEREAFTER. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TALLADEGA, ALABAMA, AS FOLLOWS:

**SECTION I:** That Ordinance No. 1667, Section 29 through Section 30 as adopted by the City Council of the City of Talladega, Alabama on the 16<sup>th</sup> day of November 2009, be amended, so that as amended shall read as follows:

**SCHEDULE "L" – Itinerant Sellers/Fruit & Vegetable Road Side Sales/Door to Door Sales**

As pertains to Itinerant Sellers:

- (a) Shall be charged a license fee in the amount of \$200.00 per week.
- (b) This license will be limited to the weeks of the Spring and Fall NASCAR races. The week will begin on the Sunday prior to the race and end on the Sunday of the race.
- (c)

As pertains to Fruit & Vegetable Roadside Sales:

- (a) Those vendors not able to present a “Growers Permit” shall be charged a license fee of \$100.00 per business license year.
- (b) This license will allow sales of not more than 180 days during the business license year.
- (c)

As pertains to Door to Door Sales

- (a) Shall be charged a license fee in the amount of \$250.00 per business license year.
- (b) This license will allow sales of not more than 90 days during the business license year.
- (c) The hours of operation are limited to 8:00 a.m. until 6:00 p.m., or dark, whichever occurs first.

**SECTION II:** This ordinance amendment shall take effect immediately upon its passage and publication, as provided by law.
